Consignment Agreement

REAL DEAL COLLECTION provides an all-inclusive consignment process to sell your authentic, Balenciaga handbags and accessories through our Web site. For those unfamiliar with the term consignment, we will sell your item(s) in return for a percentage of the amount after the sale is complete. Please read this agreement carefully to ensure a long and happy relationship.

Item Criteria

- 1) We accept only authentic BALENCIAGA handbags and/or small leather goods. No replicas, inspired, or otherwise counterfeit items will be considered, accepted, or sold.
- 2) Used items must be clean and in good, saleable condition. Some light restoration or repair is acceptable, but no completely re-dyed items will be accepted.

Process

Real Deal Collection will be responsible for the promotion, care and customer service associated with selling your item(s), including: authentication, market price evaluation, professional photography, detailed description, Internet listing, E-mail promotion, customer communication, secure packaging, shipping and insurance of your property.

Consignment Fees

Fees only apply to items sold. We charge a low commission rate of 30% of the net selling price (listed price less any coupon or promotional discount, if applicable) plus a listing fee of \$25. We cover sales transaction expenses such as credit card fees, PayPal fees, Google Checkout fees, shipping and packaging costs and all the process costs detailed above to sell your item(s). There is no charge to you if your item does not sell.

Term & Pricing

Each item is posted on our site for a minimum of 90 days:

- Initial price determined according to current market value through our research.
- After 30-45 days, the price may be lowered by 0-20% based on market conditions.
- After 90 days, we can return your item or discuss further discounts to help it sell.

You may contact us at any time to discuss pricing and selling options, such as deeper discounts for a faster sale, using the item as a promotional feature, or including additional photos, etc.

Cancellation

Because of our work and time invested, there is a \$50 cancellation fee for each item you want returned before it has been listed for sale for at least 90 days. If your item does not sell within 90 days, you may request for us to return it to you at no charge or you can allow it to remain for sale for an additional period of time.

Payment(s)

Consignors are paid at least twice a month via business check from us mailed after the buyer has received the item, or electronically through bank wire transfer or PayPal eCheck. If you would like to use your consignment payment for store credit, please notify us via E-mail.

Trade-In

If you are interested in converting your consigned item(s) to trade-in for B-Bag Bucks store credit, please E-mail us. Only bags and accessories in excellent or better condition will be considered for trade-in. B-Bag Bucks store credit can be redeemed immediately towards the purchase price of any item(s) in the shop. You do not have to wait for the trade-in item to sell first. B-Bag bucks do not expire. Not every consigned item is automatically eligible for trade-in. We will offer you a quote of B-Bag Bucks for eligible items upon request. Due to changing market conditions, our offer of B-Bag Bucks store credit must be accepted within seven days of the offer date, otherwise the offer shall be considered expired.

Disclaimers

Although we take every precaution to protect your items against loss or damage while they are in our care, Real Deal Collection is not responsible in the event of theft, fire, flood, or act of nature while in our possession. We will file an insurance claim with our insurance company to recover damages for your loss, but we cannot guarantee that you will recover any monies for your lost or damaged item.

We put in a tremendous amount of time researching the authenticity of each item. Any item that cannot be authenticated with complete confidence will be refused. We reserve the right to refuse any item that does not meet our standards and it will be returned to you at your cost. We are very confident in our authentications, however, in the unlikely possibility that your item is found to be a reproduction after its sale, you as the consignor agree to be responsible for and cover any damages that Real Deal Collection may encounter as a result.

We are not responsible for any item lost or damaged by the carrier during shipment to us. Please be sure to pack your items securely and send parcels with a tracking number, insurance and signature upon delivery. International consignors will be responsible for any import taxes, customs fees or handling fees associated with international deliveries.

By signing this agreement, you hereby affirm agreement with all of the points outlined in this document, and that you are the lawful owner of all item(s) you are consigning with us. This agreement can be terminated upon receipt of written notice signed by you, subject to the cancellation clause described above.
